ABOUT THE PARADE

The Greater New Haven St. Patrick's Day Parade is the 6th oldest St. Patrick's Day parade in the United States. The first New Haven St. Patrick's Day Parade stepped off in 1842. 2026 will mark the 182nd anniversary of the first New Haven St. Patrick's Day Parade (with two years off due to the COVID-19 pandemic). Our community has grown, our cultural complexion has changed, and the parade has stayed constant and relevant. Popular for young and old alike, Parade Day draws up to 300,000 spectators to New Haven's city streets along the parade route and is considered Connecticut's largest single day spectator event.

With the support of WTNH, viewing is not limited to those who are able to attend in person. WTNH broadcasts the parade live with a rebroadcast on St. Patrick's Day. WTNH highlights our parade leading up to the parade with television features, magazine articles and employs multimedia exposure. Local newspapers and their websites, as well as radio stations, announce and feature our Grand Marshal, the parade and parade supporting events.

The parade committee, formally known as the **Associated Irish Societies**, is a volunteer, charitable organization with 501(c)(3) status, making sponsorship and funding tax deductible. Parade Day brings over 3,000 multicultural marchers from the New Haven area, Connecticut and surrounding states to participate in a family-friendly event free to the public. Through tourism and consumerism, the parade generates \$2 million in revenue for local companies.

PARADE DAY

Families waiting for the parade will enjoy entertainment and activities for children including a petting zoo, magic shows, yard games, and more. The Family Fun Zone offers family-friendly portable bathrooms and is in close proximity to a stroller-friendly designated family viewing zone located on Church Street. The Family Fun Zone provides unique opportunity for an onsite booth, tent or table with company signage and opportunities for your company staff to distribute your product or branded promotional items to the spectator foot traffic along with a children's activity.

PARADE BALL

The Greater New Haven St. Patrick's Day Parade Ball is held annually to honor the Grand Marshal and other award recipients. 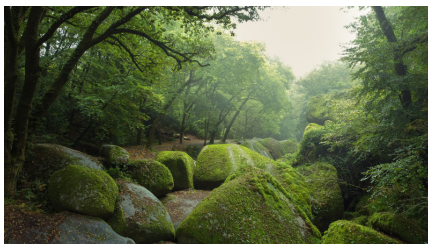

Standard Terms of Sponsorship

(Effective Date July 1, 2023)

for agreeing to be a sponsor of the Greater New Haven Saint Patrick's Day Parade. The Greater New Haven Saint Patrick's Day Parade (the "**Parade**") is a product of the Associated Irish Societies, Inc. ("Organizer"). By electing your sponsorship you agree to be bound by the following terms.

For purposes hereof, the following terms have the following meanings:

"Mark" means any trademark, trade name, service mark, design, logo, domain name or other indicator of the source or origin of any product or service.

"Sponsorship" means the agreement to provide the Sponsorship Benefits in exchange for the Sponsorship Fee and is contingent upon your meeting the Sponsorship Obligations hereunder.

"Sponsor Obligations" means the Sponsor's obligations as set forth in the applicable accompanying sponsor packet or material.

"Sponsorship Benefits" means the benefits Organizer is required to provide to Sponsor under the chosen sponsorship category.

"Sponsorship Fee" is the fee payable by Sponsor to Organizer under the sponsorship package. The Sponsor agrees to pay the Sponsorship Fee as agreed.

Term. License Grants. It being understood that the Sponsor's Mark may appear post the Term on the Organizers Website in historical references to the Event. Organizer shall use the Sponsor's Marks solely in accordance with any trademark usage guidelines and quality control standards provided by Sponsor as the same may be updated from time to time.

Sponsor use of Affiliation with Organizer. The Sponsor acknowledges that the Organizer is a not for profit entity recognized under section 501(c)(3) of the Internal Revenue Code. While the Organizer consents to the use of its name and Marks in conjunction with the Sponsors marketing related to the Event no use of its marks may be made that

would in any manner be inconsistent with its tax status. Further, the Sponsor agrees to not in any way use its affiliation with the Organizer hereunder in a manner that would be inconsistent with the Organizer's mission as the organizer of the Greater New Haven Saint Patrick's Day Parade. In this regard the Sponsor will not use the Mark or its agreement hereunder to promote lude, unlawful, unethical or in any manner that would cast the Organizer, the event or the Greater New Haven Saint Patrick's Day Parade in a poor public light or otherwise adversely affect the reputation of the Organizer all as determined in the Organizers sole and absolute discretion.

Termination. Either party may terminate this Agreement, immediately upon written notice to the other party if:

the other party materially breaches this Agreement, and such breach: (A) is incapable of cure; or (B) being capable of cure, remains uncured for ten (10) days after the non-breaching party provides the breaching party with written notice thereof; or

On expiration or earlier termination of this Agreement:

all licenses granted hereunder will also terminate and each party shall immediately cease using the other party's Marks and return to the other party such other party's confidential information, and the parties will be relieved of their respective further obligations hereunder; and

(C) The provisions set forth herein, will survive any expiration or termination of this Agreement.

Representations and Warranties.

Each party represents and warrants to the other party that: (i) it is duly organized, validly existing and in good standing as a corporation or other entity as represented herein under the laws and regulations of its jurisdiction of incorporation, organization or chartering; (ii) it has the full right, power and authority to enter into this Agreement, to grant the rights and licenses granted hereunder and to perform its obligations hereunder; (iii) the execution of this Agreement by its representative whose signature is set forth at the end hereof has been duly authorized by all necessary corporate action of the party; and (iv) when executed and delivered by both parties, this Agreement will constitute the legal, valid and binding obligation of such party, enforceable

against such party in accordance with its terms. Organizer further represents and warrants that the Organizer Marks and Sponsor's use thereof in accordance with this Agreement will not infringe, misappropriate or otherwise violate any rights of any third party.

Sponsor further represents and warrants that the Sponsor Marks and Organizer's use thereof without alteration and otherwise strictly in accordance with this Agreement will not infringe, misappropriate or otherwise violate any rights of any third party.

Indemnification

Sponsor shall indemnify, defend and hold harmless Organizer and officers, directors, employees, agents, successors and assigns (each, an "**Organizer Indemnitee**") from and against all any and all claims resulting from any action arising out of or related to: (i) Organizer using the Sponsor material, solely as used, presented, displayed and distributed without alteration and otherwise in strict compliance with this Agreement ; (ii) Sponsor's breach of any representation, warranty, covenant or obligation to Organizer under this Agreement or (iii) claims of any person or entity against Organizer for collection of money or damages arising out of obligations related to the Event that are the express responsibility of the Sponsor as Sponsor Obligations as set forth in the materials related to the Sponsorship. This indemnity to include but be not limited to the Organizer's reasonable attorneys fees and costs of defense of any claim.

Force Majeure. Neither party will be liable or responsible to the other party, or be deemed to have defaulted under or breached this Agreement, for any failure or delay in fulfilling or performing any term of this Agreement, when and to the extent such failure or delay is caused by any acts of God; flood, fire or explosion; war, terrorism, invasion, riot or other civil unrest; embargoes or blockades in effect on or after the date of this Agreement; national or regional emergency; strikes, labor stoppages or slowdowns or other industrial disturbances; passage of law or governmental order, rule, regulation or direction, or any action taken by a governmental or public authority, including but not limited to imposing an embargo, export or import restriction, quota or other restriction or prohibition; or national or regional shortage of adequate power or telecommunications or transportation facilities; (each of the foregoing, a "**Force Majeure**"), in each case, provided that (A) such event is outside the reasonable control of the affected party; (B) the affected party provides prompt notice to the other party, stating the period of time the occurrence is expected to continue; and (C) the affected party uses diligent efforts to end

the failure or delay and minimize the effects of such Force Majeure.

General

Upon a party's reasonable request, the other party shall, at the requesting party's sole cost and expense, execute and deliver all such documents and instruments, and take all such further actions, necessary to give full effect to this Agreement.

Notices to either party may be sent to the address provided. Notices are effective upon receipt.

This Agreement, together with any attachments hereto, constitutes the entire agreement of the parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings and agreements, whether written or oral, with respect to such subject matter. This agreement shall not be modified or amended nor shall any right or duty hereunder to assigned, delegated, or transferred without the express written consent of all parties hereto.

This Agreement is for the sole benefit of the parties hereto and their respective permitted successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person any legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this Agreement. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Connecticut without giving effect to any choice or conflict of law provision or rule (whether of the State of Connecticut or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of Connecticut. Any legal suit, action or proceeding arising out of or related to this Agreement or the licenses granted hereunder shall be instituted exclusively in the federal courts of the United States or the courts of the State of Connecticut in each case located in the city of New Haven and County of New Haven, and each party irrevocably submits to the jurisdiction of such courts in any such suit, action or proceeding. In the event that any action, suit, or other legal or administrative proceeding is instituted or commenced by either party hereto against the other party arising out of or related to this Agreement, the prevailing party shall be entitled to recover its reasonable attorneys' fees and court costs from the non-prevailing party.
